

#### JANUARY BOARD MEETING in brief...

- One-day meeting held at Brentwood Hotel
- Apologies from TWP who were not in attendance
- Balanced Scorecard lacking quantifiable data for Coach accreditation. Judge accreditation - Trainee Judges above target, however well below in accreditation local and national qualifying.
   Membership numbers meeting target and both Coach and Judge numbers have increased.
- Association Mentors to follow up with Associations for Life Member and Volunteer numbers for Membership stats. Projected figures indicate another increase in membership this season.
- Report from Working Party Simplification of Judging, no progress on Display sheets or seating of Display Judges. Next meeting will focus on the Training and Education of Judges
- Report from Working Party Level Two, now Coach Development Programme, received from CEO and Technical Manager who met recently and are progressing the work. Board approved a session at the Admin Workshop for presenting an overview of the Coach Development Programme.
- Upcoming Workshops Combined Coach/Judge in September and Admin Workshop in June
- Reports from TWP clarification on 'electronically sent music for NZ Championships going forward, Technical Manager as Acting Director of Coaching communicated with Coaches, via Coaching Coordinators, observations at Island Championships, Director of Judging reported on issues at Island Championships, 3 Judges Shadow Judged at each Island Championship and 4 Judges completed National Qualifying accreditation. 4 Trainee Judges have successfully Qualified in Auckland, Taranaki and Otago
- Board approved recommendation for Bars to be presented for Judges adjudicating at Island Championships
- 8 of 10 Associations have returned a financial surplus and Board Mentors will continue discussing trend statements presented by Director of Finance with their Associations. Director of Finance will still mentor Associations at risk
- Group for Change work slowed with timelines for May/June outcomes to come. An independent review of social media/website to be undertaken and recommendations from the review will be presented to the May Board meeting to consider.
- Risk Register reviewed, and risks adjusted (some less and some greater). Board to look at Risk #2 at May Meeting and determine new mitigation strategies to reduce risk of Un-skilled Volunteers.

Good governance is not firefighting or crisis-management. Instead of opting for ad-hoc solutions the need of the hour is to tackle the root cause of the problems.
